VI. ELIGIBILITY CRITERIAS

- 1) Applicant should be owner of the bus/minibus.
- 2) Bus/minibus should have valid Stage Carriage permit to operate on intra-state route.
- 3) Bus/minibus should have a valid Fitness Certificate.
- 4) Bus/minibus should have a valid Road tax Certificate.
- 5) Bus/minibus should have a valid Passenger tax Certificate.
- 6) No prosecutions remarks should be booked against the bus/minibus.
- 7) Bus/minibus should have operational kilometer certified by concerned office of permit issuing authority
- 8) Bus/minibus should be in operation for more than 27 days a month
(In case kept off road in case of repairs/maintenance for more than two days prior intimation to be given to licensing authority).

Note: Beneficiaries covered under this scheme shall not be entitled for benefits under any other government schemes and there should be **No** increase in road fair in current financial year.
