## VI. ELIGIBILITY CRITERIAS

- 1) Applicant should be owner of the bus/minibus.
- 2) Bus/minibus should have regular stage or contract carriage permit.
- 3) Bus/minibus should have a valid Fitness Certificate.
- 4) Bus/minibus should have a valid Road tax Certificate.
- 5) Bus/minibus should have a valid Passenger tax Certificate.
- 6) No prosecutions remarks should be booked against the bus/minibus.
- 7) Bus/minibus should be covered for more than 15yrs by regular permit from the date of registration.
- 8) Bus/minibus Should be in operation for a continuous period of past 3 yrs as stage or contract carriage
- 9) Bus/minibus should be owned by applicant for past 3 yrs.
- 10) New Bus/minibus should be built within state of Goa.
- 11) Goa sightseeing buses and contract carriage for school children having permit are also eligible.
- 12) Relaxation of provisions for the State owned Corporations (KTCL) bus/minibus which are more than 12 yrs old from the date of its registration.

**Note:** Beneficiaries covered under this scheme shall not be entitled for benefits under any other government schemes and Bus purchased under this scheme cannot be sold for at least 5 yrs.
